## THE ASSOCIATION FULL PRIVACY POLICY FOR MEMBERS AND THEIR MEMBER CONTACT PERSONS

This full privacy notice sets out how we collect, use and share your personal data, your rights in relation to which you have access and how you can exercise them. ### WHO IS THE DATA CONTROLLER?

The data controller of your personal data is the *Hungarian Competition Law Association (1061 Budapest, Dalszínház utca 10 1/3, Hungary, "the Association", "Association" or "we")*, e-mail: [info@versenyjog.hu](mailto:info@versenyjog.hu)

### WHAT PERSONAL DATA DO WE COLLECT?

Personal data is obtained directly from our members, their contacts, participants in our programmes, or from public sources (such as company registers). These categories of data include:

- **Contact details:** such as your name and contact details, such as your email address, or your physical or postal address;
- **Contact details:** such as details about your activity, position, such as your employer, your job title and title, place of work, if you provide them;
- **Membership data:** such as membership data about you, such as the date of joining and leaving the association, data about your association activity.
- **Banking, financial data:** such as bank account number, tax number, membership fee payment details; payment details for services;
- **Requested services data:** date of conference registration, requested services data (as attendance); specific requests, roster data.
- **Application data:** CV, academic data, abstract of presentation, list of publications.
- **Communication data:** data about your communication preferences.

The provision of personal data is necessary for membership administration and to contact you. If you do not provide the data, you will not be able to participate in the activities of our Association.

### FOR WHAT PURPOSES DO WE PROCESS PERSONAL DATA?

We process your personal data because it is necessary to.

- i. keeping a register of members for the purpose of exercising the rights and obligations arising from membership of the Association and enforcing legal claims relating to membership
- ii. to communicate with you in the context of the Association's objectives, for the purpose of sending you professional newsletters and publications
- iii. to organise participation in conferences and professional events;
- iv. for the management and evaluation of professional applications launched by the Association;
- v. transfer of data to the International League of Competition Law (LIDC) for the use of its member portal
- vi. to comply with legal obligations (tax, accounting or statutory reporting).

### WHAT ARE THE LEGAL BASES FOR DATA PROCESSING AND WHAT ARE OUR LEGITIMATE INTERESTS IN DATA PROCESSING?

We rely on the following legal bases when processing personal data about you:

- **Contract:** If you are an individual member or participate in our programs as an individual, the legal basis for processing your personal data is usually Article 6(1)(b) GDPR (i.e. processing necessary to establish or terminate a membership relationship at your request, to fulfil membership rights and obligations or to provide services you

request). The provision of personal data is voluntary, but without it we may not be able to establish or maintain a membership relationship ("**Contractual Legal Basis**").

- **Our legitimate interest:** our overriding legitimate interest in facilitating the ongoing membership relationship with you or your employer, promoting and monitoring the membership relationship with you (or your employer), exercising the rights and obligations arising from the membership relationship with you (or your employer) and bringing, enforcing or defending any legal claims based on that relationship, based on Article 6(1)(f) of the GDPR ("**Legitimate Interest Legal Basis**").
- **To comply with a legal obligation:** processing of your data may be required for tax or accounting purposes or on the basis of a request by a public authority or a court on the basis of Article 6(1)(c) GDPR ("**Legal ground for a legal obligation**").
- **Consent:** professional newsletters and publications are sent to you on the basis of your consent, the legal basis of which is Article 6(1)(a) of the GDPR. You may withdraw your consent at any time and the withdrawal of your consent shall not affect the lawfulness of the processing carried out before the withdrawal of your consent ("**Consent**").

the Association has carried out a balancing of interests test prior to processing where the Association relies on a legitimate interest in the processing of personal data. In carrying out the balancing of interests, the Association took into account its internal organisational structure, internal operating rules and requirements, its related legal obligations,

the purposes of the processing, the scope, nature and type of personal data processed, the expected amount of data and the expected number of data subjects, and the impact of the envisaged processing on the rights and freedoms of data subjects.

<p><b>Exercising rights and obligations arising from membership of the association, maintaining contacts and enforcing legal claims related to membership</b></p>	<p>Our association has a compelling legitimate interest in fulfilling our obligations arising from our membership relationship with legal entity association members, and in enforcing our rights and monitoring the existing membership relationship, as well as in bringing, enforcing and defending any legal claims relating to that relationship. In this context, it is necessary to process the personal data of member employees, agents and officers who have contact with us. This processing does not go beyond the scope of what is normal in the context of a membership relationship and is therefore also in line with the expectations of the data subjects. If you have a membership relationship with us, you can reasonably expect that we will process your data in the context of, and for the purpose of facilitating, the performance of that membership relationship, including contacting you. On the basis of the balancing of interests test carried out, we established that the proposed processing will not disproportionately infringe your rights and freedoms and we will therefore rely on our legitimate interest in processing your data.</p>

## WHO DO WE MAKE YOUR PERSONAL DATA AVAILABLE TO?

Your data will be accessible to our senior officers (President, Secretary General) within the Association organisation. Outside the Association organisation, we may share your personal data with the following categories of recipients:

- *For the Ministry of Justice:* the Association is a strategic partner of the Ministry of Justice. If the Association is involved in a legislative consultation and you have provided us with your views on the consultation, we will forward them to the Ministry for consultation.
- *Hungarian Competition Authority:* the Association cooperates with the *Hungarian Competition Authority*. We will make your application data available to the Competition Culture Centre or other competent departments of the *Hungarian Competition Authority* in order to fulfil our obligation to account for your application if you submit one to us.
- *International Competition Law League (LIDC, Switzerland):* the Association is a member of the International Competition Law League. If you are involved in the Association's professional activities concerning the LIDC, such as the production of international reports, your name and contact details will be forwarded to the LIDC. The LIDC Privacy Notice is available here: <https://www.ligue.org/privacy-policy>. Beyond this, we process personal data on the basis of your consent (Article 6(1)(a) GDPR) in order to transfer your data to LIDC in accordance with your wishes for the purpose of accessing the LIDC member portal (<https://www.ligue.org/login/>)
- *To certain third parties:* banks in Hungary and external advisors (e.g. lawyers in Hungary) may transfer personal data about you, in particular for the purposes of administering and paying payments, communicating with you and third parties, and responding to and complying with formal requests and legal claims.
- *External service providers:* the Association uses third party services to support its internal processes. For the purposes of the system or service and on the basis of an appropriate data processing agreement between the Association and the service provider, personal data may be accessible to such service providers. Thus, your data will be disclosed to accountants in Hungary; Intronet Kft. (1023 Budapest, Frankel Leó út 21-23, 1st floor 1), which provides e-mail hosting services, and Hegymegi-Barakonyi and Fehérváry Law Office (Budapest, Dorottya u. 6, 1051), which provides back office services to the Association. The Lexology service is provided



by Globe Business Publishing (New Hibernia House, Winchester Walk; London, SE1 9AG UK), acting as data processor.

## WHAT KIND OF DATA TRANSFER GUARANTEES DO WE APPLY?

If we transfer your personal data to third countries outside the European Economic Area (EEA), we will ensure that the personal data is protected to the same level as under EU data protection rules (e.g., such as the EU General Data Protection Regulation, GDPR). ## HOW LONG DO WE KEEP YOUR PERSONAL DATA?

We will retain and process the personal data we collect from you for as long as the related processing purpose, in particular our legitimate interest, exists (for example, for the period of time necessary to comply with tax and legal requirements in relation to the service provided to you). Personal data will be deleted from our records or appropriately anonymised when no longer needed. If you have a membership relationship with us, we will retain your personal data for the duration of your membership and thereafter for the duration of the civil statute of limitations (i.e. 5 years). Personal data held in contracts, communications and business correspondence are subject to legal retention requirements, which require a minimum retention period of eight years for accounting documents. However, access to personal data will then be limited

## WHAT RIGHTS DO YOU HAVE?

You have the following rights in relation to our processing:

- 1. Right of access:** you have the right to receive feedback from us as to whether your personal data is being processed and, if such processing is ongoing, you have the right to access your personal data. The right of access includes, inter alia, the following information: the purposes of the processing, the categories of personal data processed and the recipients or categories of recipients to whom or which the personal data have been or will be disclosed. You have the right to request a copy of your personal data that are subject to processing. If you request additional copies, we may charge you a reasonable fee based on administrative costs.
- 2. Right to rectification:** you have the right to have inaccurate personal data about you rectified at your request. Depending on the purpose of the processing, you may have the right to request that incomplete personal data be completed, including by means of a supplementary declaration.
- 3. Right to erasure (right to be forgotten):** you have the right to request the erasure of your personal data, in which case we are obliged to comply with your request.
- 4. Right to restriction of processing:** you have the right to request the restriction of the processing of your personal data. In such cases, the data concerned will be marked and processed only for specified purposes.
- 5. The right to data portability:** you have the right to receive the personal data we have about you in a structured, commonly used, machine-readable format, and the right to transfer this personal data to another controller without our hindrance.
- 6. Right to object:**

**You have the right to object to our processing of your personal data at any time on grounds relating to your particular situation, in which case we may no longer process your personal data. Where you have the right to object and you exercise that right, we will no longer process your personal data for such purposes. There is no cost for exercising this right.**
